

Lassus August 2019 Sweepstakes Official Rules

NO PURCHASE NECESSARY TO PLAY OR WIN A PRIZE.

1. **HOW IT WORKS:** From August 13, 2019 – October 7, 2019, or while supplies last (“the Sweepstakes Period”), contestants may visit participating Lassus Handy Dandy (“Sponsor”) locations and enter for a chance to win one of the prizes specified below. The odds of being selected as a winner depend upon the number of entries throughout the duration of the sweepstakes.
2. **ELIGIBILITY:** Only open and offered to legal U.S. residents who reside in Indiana and who are 18 years of age or older at the time of entry and who are, or who register to become a Hometown Rewards member with a valid email or phone number on file (“Contestant”). Only \$1 Emerald Mine 5X, \$2 Ruby Mine 10X, \$5 Sapphire Mine 20X, and \$10 Diamond Mine 50X Scratch-off tickets are eligible and, therefore, will earn entries into the Sweepstakes.
