

Lassus Olympics Sweepstakes Official Rules

NO PURCHASE NECESSARY TO PLAY OR WIN A PRIZE.

1. **HOW IT WORKS:** From July 23, 2021 through August 8, 2021 or while supplies last (“the Sweepstakes Period”), contestants may visit participating Lassus (“Sponsor”) locations and enter for a chance to win one of the prizes specified below. The odds of being selected as a winner depend upon the number of entries throughout the duration of the sweepstakes.
2. **ELIGIBILITY:** Only open and offered to legal U.S. residents who reside in Indiana, Ohio, or Michigan and who are 18 years of age or older at the time of entry and who are, or who register to become, a Lassus Rewards member with a valid email and phone number on file (“Contestant”). Employees of Lassus Bros. Oil, Inc., immediate family members, and individuals residing in their same household are not eligible to participate. Void where prohibited.
3. **HOW TO PLAY:** Scan or swipe your active LASSUSGO card, scan your Lassus Rewards Mobile ID, or enter your unique & registered phone number when you make a purchase at a participating Lassus store in Indiana or Ohio during the Sweepstakes Period. Every non-excluded LASSUSGO item in the store you purchase while having your Lassus Rewards status recognized will equal one (1) entry. See Lassus.com for the LASSUSGO Rewards program’s eligible items for eligible entries.

Lassus will select five (5) winners and five (5) alternates for this sweepstakes. Winners will be notified by email and/or phone. Upon notification, a winner will have five (5) business days to respond and claim the prize. If a selected winner fails to respond within five (5) business days, the selected winner will be deemed to have forfeited the prize and an alternate will be selected and notified in accordance with this section. Winners must provide valid identification when claiming any prize. Winners may not substitute, assign or transfer prize or redeem prize for cash, but Lassus

reserves the right to substitute prize with prize of equal or greater value if advertised prize becomes unavailable.
