

## Lassus Summer Fun Prize Pack Sweepstakes Official Rules

NO PURCHASE NECESSARY TO PLAY OR WIN A PRIZE.

1. **HOW IT WORKS:** From July 6, 2021 – August 30, 2021 (“the Sweepstakes Period”), contestants may visit participating Lassus Handy Dandy (“Sponsor”) locations and enter for a chance to win one of the prize packs specified below. The odds of being selected as a winner depend upon the number of entries made in the sweepstakes.
2. **ELIGIBILITY:** Only open and offered to legal U.S. residents who reside in Indiana and who are 18 years of age or older at the time of entry and who are, or who register to become a LASSUSGO Rewards member with a valid email and phone number on file (“Contestant”). Employees of Sponsor, the State Lottery Commission (“Commission”) and/or IGT, the integrated services provider of the Commission (together with the Commission, “Hoosier Lottery”), and immediate family members and individuals residing in the same household as the above are not eligible to participate.
3. **HOW TO PLAY:** Customers use their Lassus Rewards account (Mobile ID, Loyalty ID, LASSUSGO card, or LASSUSGO key tag) when making a purchase at a participating Lassus Handy Dandy store in Indiana during the Sweepstakes Period. Every \$10- Million Dollar Spectacular Scratch-off ticket purchased while using a LASSUSGO Rewards card equals one (1) entry.

the rights to substitute prize with prize of equal or greater value if advertised prize becomes unavailable.
